



HEALTH INSURANCE FOR SWISS NATIONALS LIVING ABROAD FOR WHOM INSURANCE IS NOT COMPULSORY IN SWITZERLAND

In principle, the Federal Law on Health Insurance holds that health insurance is solely mandatory for those living in Switzerland. The agreements concluded with the EU and EFTA have brought about several changes to this principle concerning certain categories of residents of EU or EFTA member States, i.e. pensioners, cross-border commuters as well as those receiving unemployment benefits in Switzerland.

For other categories of residents abroad the system remains the same as before, i.e. they do not have much legal backing for health insurance coverage with the Swiss insurance companies. The health insurance funds do have the possibility however (but not the obligation) to provide health insurance proposals for Swiss abroad.

We would recommend that you get in touch directly with your insurance company to ask if it does offer the possibility of health insurance abroad.

If this were not the case, we can suggest some useful addresses of companies who propose an international health insurance.
